

## **Terrorism Risk Insurance Program Reauthorization Act of 2007**

The following chart identifies the states that are allowing the submission of terrorism rules on an expedited basis in order to comply with the Terrorism Risk Insurance Program Reauthorization Act of 2007 (TRIPRA). This chart will be updated as additional states announce that expediting filings will be allowed. A link to each state bulletin that announces expedited filing procedures is provided at the bottom of this document.

This chart will also be updated as revised AAIS Terrorism Supplements are filed. An advance copy of each revised Supplement is being released via an AAIS bulletin shortly after the submission of the corresponding filings. Such bulletins are posted to *AAISdirect*; each bulletin recipient receives an e-mail notice that identifies the newly released bulletins on the day of the posting.

In those states where expedited filings are allowed, follow-up bulletins will be posted to *AAISdirect* to announce the availability of the revised Supplements once the state-assigned filing numbers are available. These bulletins will provide the AAIS filing number and any applicable state file numbers. In those states where expedited filing is not allowed (or not allowed at the time of filing), AAIS bulletins will be posted as filings are approved or deemed available.
